The Diploma in Adult Care Level 3 has been written in line with the minimum requirements set out by Skills for Care and Skills for Health and confirms the competence of those who work in health and adult care services in England.

The Level 3 Diploma in Adult Care (RQF) will also link with the knowledge and skills required within the Adult Care Sector supporting roles such as lead personal assistant and lead adult care worker.

Duration on Programme

• 9 - 12 months depending on experience.
